

This has involved promoting rural issues, acting as a 'rural voice' and in supporting many organisations and individuals by running and managing projects that are of benefit to people, particularly the disadvantaged.

I would like to make a special mention of our staff. They have worked extremely hard to implement the new direction and create benefits for customers and beneficiaries. Some exciting new projects have been launched and new alliances have been created accompanied by new sources of funding.

There has also been change on our Board. In October 2015 Sally Black MBE and Dr Hilary Talbot retired both after many years of service for which we are extremely grateful. The following people have joined the Board and have brought vital experience and knowledge of life and issues in rural Northumberland; Elizabeth Elliott, Mark Griffin, Miles Middleton, Councillor Anthony Murray, Jane Pannell and Valerie Vaughan.

# **2015/16 SNAPSHOT**

"Challenging times these may be, but there are opportunities to be grasped and the need for CAN's services has never been so great"

CAN has been very busy throughout 2015-16 both on traditional core areas of work and on a range of new activities. Highlights include:

- We have been supporting **village halls and community buildings** since we were formed in 1951. This remains at the heart of what we do. Around 250 community buildings exist across Northumberland offering vital facilities for community activities. Throughout the year we have supported management committees in one-to-one case work, good practice resources and training, funding bids, asset transfers and Village SOS projects. We continued to work closely with Northumberland's two village hall consortia in the North and West of the county and assisted committees in achieving the Hallmark standard.
- Our direct partnership with the **Northumberland Association of Local Councils (NALC)** is hugely valued and fundamental to the way we work. We have provided advice, training and a wide range of support throughout the year including assisting Councils in accessing resources from the government's Transparency Fund.
- We have developed a range of activities in relation to fuel poverty and energy efficiency including: re-launching our **OilCAN** joint heating fuel procurement scheme growing membership to over 500; launching **EnergyCAN**, a mechanism for helping organisations and individuals to secure cheaper electricity and gas contracts; promoting the Central Heating Fund and Warm Up North's free boiler scheme.

- We delivered a successful **Warm Hubs** pilot project, supported by Northern Gas Networks: Warm Hubs are places within local communities where vulnerable people can be assured of finding a safe, warm and friendly environment in which to enjoy a healthy good value meal, and the company of other people. The project received the coveted Community Action Award in January a national award recognising excellence and innovation in tackling fuel poverty and improving energy efficiency among vulnerable households.
- In partnership with the North East Enterprise Agency Ltd (NEEAL), we secured funds from the Prince's Countryside Fund, North East LEP and Rural Growth Network to support the **Rural Connect** network of rural enterprise hubs in helping to make sure rural businesses are not missing out on available support.
- We ran a successful **Unemployment project** in Haltwhistle helping local unemployed people no matter what their background through group and one-to-one sessions on completing application forms, writing CVs, travel planning, preparing for interviews, interview skills, self employment and life skill development.
- We managed the Wingates **Windfarm Community Fund** and began community engagement work in relation to a new Community Benefit Fund in relation to the Ray windfarm.
- We began development work on a range of new activities and worked hard to make sure Northumberland's rural voice is heard.

## **CAN'S FINANCES**

Following a major review and restructure, 2015-16 was a second year of transition for CAN. Key targets were to maintain our financial relationship with both Defra and NALC. Both these objectives were achieved. We were also successful in achieving further diversification of our other income from a combination of grant, contract, consultancy and directly earned income.

Our annual deficit for the year was slightly reduced from 2014-15 and, more importantly, we had already secured a range of income for the ensuing year meaning that we start 2016-17 with greater confidence than for a number of years.
